Fund objective

The OMR Quilter Investors Cirilium Conservative Portfolio invests solely in the Quilter Investors Cirilium Conservative Portfolio, a sub fund of the Quilter Investors Cirilium OEIC, a UK authorised Open Ended Investment Company managed by Quilter Investors Limited. The underlying fund aims to achieve capital growth over a period of five years or more through investment in markets both in the UK and overseas. The underlying portfolio will be broadly diversified across asset classes, with exposure to equities between 0-30% and with volatility of between 3 and 7%. Investments in emerging markets tend to be volatile and are usually considered to carry a greater degree of risk than investments in established markets. This relates to dealing, settlement and custody practices, the possibility of political or economic instability, and developing legal, fiscal and regulatory structures. The underlying fund may be denominated in or hold assets in a currency other than Sterling. The performance of the fund may therefore rise and fall as a result of exchange rate fluctuations. 




