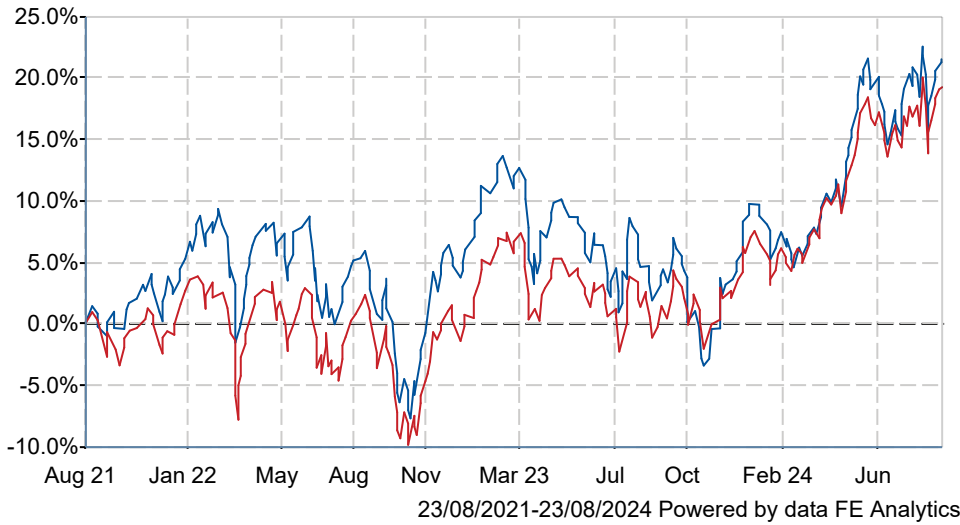


# Allianz UK Listed Equity Income C Inc

The Fund aims to generate a total return (income and capital growth) net of fees greater than that of the FTSE All-Share Index (net of fees) over a rolling 5 year period. It does this by investing in securities listed on the London Stock Exchange, although it may invest internationally and in all economic sectors. 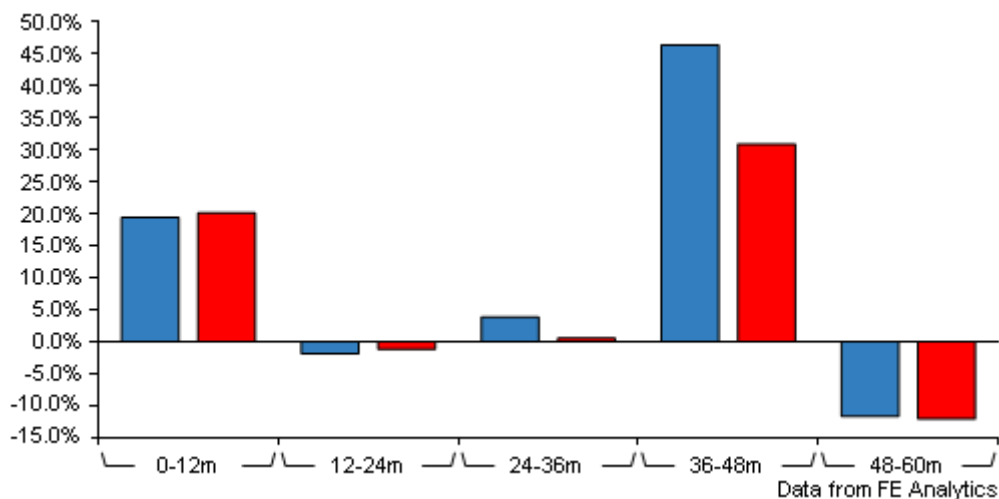

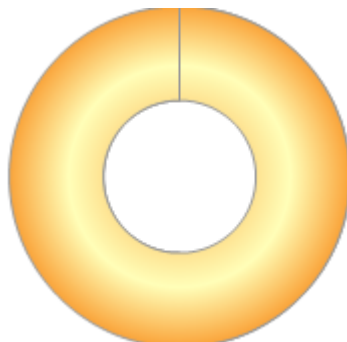

## Asset Allocation (31 Jul 2024)

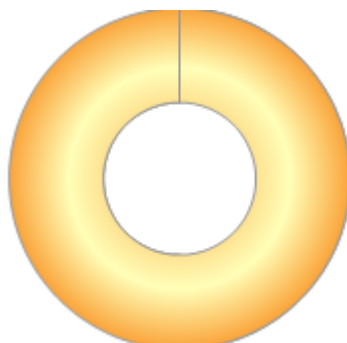

## Regional Breakdown (31 Jul 2024)

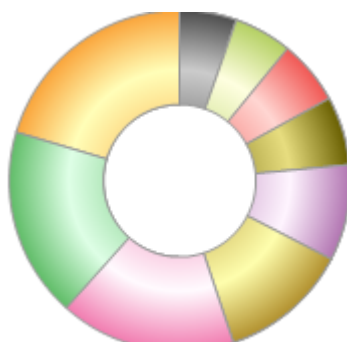
