


The Investment Manager is entitled to receive from the Company a basic fee together, where applicable, with a performance fee. The basic management fee accrues weekly and is payable quarterly in arrears. The basic fee is the lower of (i) 1% of the adjusted NAV of the Company and (ii) 1% per annum of the Company's market capitalisation. The Investment Manager will be entitled to a performance fee in respect of a performance period only if certain criteria are met. The fee is 15% of the excess returns over the FTSE Small Cap ex Investment Trusts total return + 2% pa over the rolling three year period and providing the high watermark is exceeded (which is the highest NAV per share by reference to which a performance fee was paid previously). Company secretarial services and the general administration of the Company are undertaken by Capital Sinclair Henderson Limited (CSH) for a fee for the year to 30 June 2012 of £77,000. The fee is subject to annual review based on the UK Retail Price Index. In the event that there is an increase in the issued share capital of the Company, the fee will be adjusted upwards by agreement between the Company and CSH. The agreement may be terminated by either party giving to the other not less than six month's notice at any time.




