Fund objective

The OMR Fidelity Emerging Europe, Middle East & Africa fund invests solely in the Fidelity Emerging Europe, Middle East & Africa Fund, a sub fund of the Fidelity Investment Funds, a UK authorised Open Ended Investment Company, with Variable Capital, managed by FIL Investments Services (UK) Limited. The underlying fund aims to achieve longterm capital growth through a portfolio primarily in securities of companies having their head office or exercising a predominant part of their activity in less developed countries of Central, Eastern and Southern Europe (including Russia), Middle East and Africa including those that are considered as emerging markets according to the MSCI EM Europe, Middle East and Africa Index. Investments in emerging markets tend to be volatile and are usually considered to carry a greater degree of risk than investments in established markets. This relates to dealing, settlement and custody practices, the possibility of political or economic instability, and developing legal, fiscal and regulatory structures. The underlying fund invests into a relatively small number of assets, or into individual countries or a specific market sector. Such concentrated portfolios give rise to more risk than where investments are spread across a larger number of ass...
