#### **Fund objective**

The OMR Schroder Gilt & Fixed Interest fund invests solely in the Schroder Gilt & Fixed Interest Fund. a UK Authorised Unit Trust managed by Schroder Unit Trusts Limited. The underlying fund aims to achieve a high level of income with the potential for capital growth, from investment in a diversified portfolio of sterling denominated fixed interest securities. The underlying fund invests into a relatively small number of assets, or into individual countries or a specific market sector. Such concentrated portfolios give rise to more risk than where investments are spread across a larger number of assets, countries or market sectors. The underlying fund may be denominated in or hold assets in a currency other than Sterling. The performance of the fund may therefore rise and fall as a result of exchange rate fluctuations. 


