

# Zurich Embark Horizon Multi-Asset I

#### **Fund objective**

The aim of the Embark Horizon Multi-Asset I Fund (the underlying 'Fund') is to grow investment through a combination of income and capital growth over the medium to long term (5 or more years) and to keep the fund within a designated risk profile. This Fund is one of a range of Embark Horizon Multi-Asset funds which aims to cater for investors with different risk appetites. This Fund is aligned to risk profile 1, the lowest risk profile in this range, which means that it aims to deliver income and capital growth through assets that demonstrate moderate price fluctuations, with greater emphasis placed on fixed income securities and lower exposure to equities. The Fund will be invested in collective investment schemes. Investments in collective investment schemes may also include those managed, operated or advised by the Management Company's associates. Through the investment in collective investment schemes, the Fund will be indirectly invested in a range of different asset classes. The weighting of the asset classes to which the Fund is exposed may be varied depending on the Investment Manager's views in the context of achieving the investment objective. Under normal market circumstances, between 15% and 50% of the value of the Fund will be invested in global equities, ... 


